### PROCEEDINGS OF THE WASHINGTON COUNTY BOARD OF SUPERVISORS MEETING TUESDAY, SEPTEMBER 25, 2018

Chairperson Abe Miller called the meeting to order at 9:30 a.m. in the Courthouse chambers in regular session. Items on the agenda included the following: Voter Registration Proclamation; secondary road use permit application from Mid-Prairie Student Boosters; Resolution 18-48 regarding Washington County Riverboat Grant application from City of Brighton; Resolution 18-49 regarding Washington County Riverboat Grant application from Washington County Communications; personnel change request from Washington County Conservation; Resolution 18-50 regarding Washington County Riverboat Grant application from Washington County Conservation; Resolution 18-51 regarding Washington County Riverboat grant application from Tyrone Cemetery; overview of changes in lease agreement between Federation Bank and Washington County Public Health; public comment; adjourn. Supervisors Stan Stoops, Jack Seward, Jr., Richard Young, and Bob Yoder were also present.

All motions were passed unanimously by those Supervisors in attendance unless noted otherwise.

On motion by Yoder, seconded by Stoops, the Board voted to approve the agenda as published.

On motion by Young, seconded by Yoder, the Board voted to approve, and authorize the Chairperson to sign, a Voter Registration Proclamation. The proclamation is as follows:

#### **Voter Registration Proclamation**

WHEREAS, registering to vote empowers eligible citizens to exercise their right to vote on Election Day; and

WHEREAS, while Iowa is one of the nation's leaders in voter registration and voter participation, with more than two million residents currently registered to vote, some eligible citizens have not yet registered; and

WHEREAS, this month, the Iowa Secretary of State's Office is contacting hundreds of thousands of eligible Iowans, encouraging them to register to vote; and

WHEREAS, the voter registration process in Iowa is easier and more convenient than ever before, with online voter registration, Election Day registration, and applications available through government agencies across the state; and

WHEREAS, the State of Iowa has an online voter registration system enabling citizens to register to vote and update their registration status quickly and easily, any time of day; and

WHEREAS, more than 250,000 Iowans have registered to vote for the first time in the state since January 2015; and

WHEREAS, we encourage all interested citizens and all appropriate media outlets and civic organizations to participate in this non-partisan voter registration awareness campaign to encourage the maximum participation of qualified voters in Iowa.

**NOW, THEREFORE**, on this 25<sup>th</sup> day of September, 2018, the Washington County Board of Supervisors does hereby proclaim September 2018 as National Voter Registration Month; and Tuesday, September 25th, 2018 as National Voter Registration Day.

Tyrone Cemetery Restoration – Dutch Creek Township

Public Health Administrator Danielle Pettit-Majewski informed the Board that the Washington County Public Health Board has signed a new lease with Federation Bank for office space on floors 3, 4, and 5 of property located at 102 East Main in Washington that is owned by the bank. Pettit-Majewski noted that the new lease, which begins October 1, calls for monthly rent payments in the amount of \$4,588.50 which is a \$500.00 more than the present monthly amount. Pettit-Majewski explained that the increase is due to the increase in property tax for the building as well as increased energy costs. It was noted the increased lease amount, the first since 2014, may necessitate a budget amendment. The rental fee includes water, sewer, gas, electricity, maintenance, repairs, cleaning, and reasonable amounts of garbage and trash pickup. Miller stated that the monthly rent of \$4,588.50 equates to a rate of approximately \$1.00 per square foot which he termed as quite reasonable. On motion by Seward, seconded by Stoops, the Board voted to acknowledge the change in lease agreement between Washington County Public Health and Federation Bank.

There was no public comment.
